Annex No.1

According to the existing Land Lease Methodology, when concluding a land lease agreement, the following documents shall be submitted:

- 1. An application, in which:
 - a natural person indicates name, surname, personal identification code, declared address of residence and other address where the person can be reached, address of the leased land plot and cadastral designation (if available), desired lease area and planned activity during land lease term;
 - a legal person shall indicate the name (company), legal address, registration number, address of the leased land plot and cadastral designation (if available) and the planned activity during land lease term.
- 2. In case a merchant plans to engage in commercial activities related to port functions in the territory of the Freeport of Riga, in addition to the application referred to in paragraph 1, a business plan (operational program) shall be submitted in accordance with the specified structure (Annex No.2), providing the amount of investments to be invested and the investment schedule (Annex No.4).
- 3. Commercial companies and natural persons, which plan to perform commercial activities not related to port functions in the territory of the Freeport of Riga, in addition to the application referred to in Paragraph 1, shall submit a business plan (operational program) in compliance with the specified structure (Annex No. 3).
- 4. Pursuant to Section 18, Paragraph one of the Law on Ports, when concluding agreements with a commercial company in a port, the port authority shall observe the precondition that the founders and shareholders of the commercial company shall have good reputation and a stable financial position, therefore, the following additional documents shall be submitted: a statement from the credit institution (not older than 15 days), which confirms that the financial resources of the commercial company correspond to the transactions to be performed; information on the shareholders and founders which justifies their stable financial position and good reputation.
- 5. The Freeport of Riga Authority may additionally request information and documents in connection with the issue of land lease.
