Zoning: Other area with special regulations TIN19

- An area with special regulations (TIN19) is an area where engineering preparation and ground leveling (backfilling) must be carried out before the construction process begins.
- Until the start of the construction process in the area, it is permitted to install temporary soil outcrops.




